To participate, schools register to have their production reviewed by a qualified team of adjudicators, who then provide the directors and students with valuable feedback. During the spring, CAPA presents an award showcase. Modeled after the Tony Awards®, the showcase features outstanding performances from participating high schools and celebrates their enthusiasm, dedication, and talent while encouraging participating schools to grow and continue improving their programs. Purpose

The CAPA Marquee Awards and Awards Showcase are designed to **celebrate**, **support**, and **advocate** for high school musical theatre education throughout the central Ohio community.

Goals

1. To recognize, honor, and encourage excellence in high school musical theatre through a constructive review process of nominated productions by qualified adjudicators;
2. To deliver educational workshops and advancement in dance, voice, acting, and stagecraft for high school students locally, regionally, and nationally;
3. To offer professional development and networking opportunities for students, directors, and school programs;
4. To give students an opportunity to perform on a CAPA stage;
5. To create positive attention for theatre arts and music departments at local schools and school districts; and
6. To showcase the importance of theatre arts education in our schools.

Diversity, Equity, Access & Inclusion

The CAPA Marquee Awards believe to enrich the artistic experience, educational theatre must make room on the stage, around the production table, in the orchestra, behind the scenes, and through the adjudication process for those with different backgrounds, sexual orientation, identification, cultures, and abilities. We believe that we are enriched by the unique perspective all people bring to the arts.

The CAPA Marquee Awards recognizes that there are cultural and systemic barriers that prevent complete inclusivity and equity. We are committed to identify those barriers and intentionally adapt our practices, demonstrate our efforts, and measure the results to promote inclusion and equity.

Columbus Association for the Performing Arts (CAPA) aims to present and produce artistic programming of the highest quality to serve and educate diverse audiences and feature renowned artists of all cultures; operate and maintain world-class performance venues; strengthen our arts communities by providing facilities for resident companies, and through partnership and collaboration, support those organizations; and bolster the economy of the community we serve.

How to Participate

Participant Eligibility

The CAPA Marquee Awards are open to all public, private, parochial, and charter schools producing high school musicals in central Ohio. To be eligible for participation, a school must meet the following criteria:

- **School Location**
 - High schools must be in Delaware, Fairfield, Fayette, Franklin, Hocking, Knox, Licking, Madison, Perry, Pickaway, Ross, or Union counties to participate.
- **Production Dates**
 - High school productions must take place between Thursday, October 8, 2026, and Saturday, April 3, 2027.
 - There must be more than one (1) live performance of each nominated production.
- **Production Types**
 - Schools must perform a published musical, operetta or revue (either currently held by a licensing house or in the public domain) presented with the approval or permission of the original creators, publishers, or their representatives.
 - Schools must produce one of the full-length musicals approved by the National High School Musical Theatre Awards. [\(To view click here.\)](#)

Application & Registration Fee

Applications will be available online at www.capamarqueeawards.com starting at **NOON** on **Tuesday, August 11, 2026**, and will close at **NOON** on **Tuesday, August 18, 2026**. Schools will be chosen to participate according to several factors including performance dates, previous participation, diversity, equity, access & inclusion and adherence to deadlines and program requirements during prior participation. Schools will be notified by **Tuesday, August 25** if they are selected to participate.

Once a school is accepted into the program, a non-refundable \$150 registration fee is required. **Payments must be received no later than Friday, September 25, 2027.** *Failure to pay the registration fee by September 25 may result in removal/disqualification from the program.*

Financial Assistance

We do not want a school's inability to pay to prevent participation in the program, so please contact us to discuss financial assistance options if your school is unable to pay.

Tickets to Awards Showcase

In addition to the non-refundable registration fee, the CAPA Marquee Awards requires each school to purchase 25 tickets to the Awards Showcase at the discounted student ticket price of \$15 each (\$375 total) *regardless of nominations.* **The required 25 tickets must be purchased and paid for by Friday, March 12, 2027.** *Failure to purchase and pay for tickets by this deadline may result in a school not being accepted back into the program in subsequent years.* [\(To view ticket reservation form, click here.\)](#)

Schools may purchase additional tickets at the reduced student rate of \$15. Additional ticket requests will be processed on a first-come, first-served basis and are subject to availability. If additional seats are available, they will be located with the group's orchestra seats, otherwise, they will be located wherever additional seating is available.

****Two (2) complimentary tickets** will be available for the educator/director who organized their school's involvement with the CAPA Marquee Awards. These will be located with the block of 25 tickets in the Orchestra.

School Web Portal

The school web portal is a password protected page on our website where Marquee schools can submit required documents and forms, download the handbook and other important documents, and submit photos and videos through a dedicated Dropbox link. Only the school's primary contact person is authorized to use this portal.

Here are the instructions to access your School Portal:

1. If you are a returning school and already have an account, please use the login and password from last year.
2. If you are a new school, you will receive an email from "CAPA Marquee Awards" after the School Meeting with information for how to complete your registration.
3. Once you have completed your registration, visit www.capamarqueeawards.com.
4. Click 'log in' from the top right area of the website.
5. Once logged in you will have access to your school's portal content.

Please note: To maintain the security of the web portal, the school's primary contact must agree not to share their login and password with anyone.

Rights and Permission

Proper production and musical rights must be attained to participate in the CAPA Marquee Awards/Jimmy Awards®.

Production selection must be **decided** and **communicated** to us by Friday, December 11, 2026.

Production rights must be **paid and secured** no later than Friday, January 22, 2027.

If you make any changes to the production including changes to the structure, dialogue, lyrics, casting, music, characters, story, etc., you must receive written permission from the company that owns the production rights. Upon request, you must also be able to submit written proof of permitted changes. Failure to receive permission from the publishing company and/or provide written proof if requested, may result in disqualification from awards and/or the showcase.

PLEASE NOTE: If you choose to perform a musical licensed by Concord Theatricals and you receive a nomination for Best Musical Production or Best Performer in a Jimmy Awards Qualifying Role, we must receive permission from Concord Theatricals for your requested musical number(s) no later than Friday, April 23, 2027, in order for your production/students to perform the requested number(s) in the Showcase.

Music Rentals

Each school should plan to retain copies of the full conductor's score, libretto, and the individual instrument books in the event they receive a nomination for Best Musical Production and/or a nomination for Best Performer in a Jimmy Awards Qualifying Role and are invited to perform at the CAPA Marquee Awards Showcase. Arrangements will be made by Columbus Association for the Performing Arts with all participating licensing houses for schools to retain their music rentals through the CAPA Marquee Awards at no additional cost.

Group and Production Photos

Photo Deadlines:

- Fall Shows: If the last day of your production falls between Thursday, October 8-Sunday, December 13, your photos will be due by **Friday, December 18**.
- Winter Shows: If the last day of your production falls between Thursday, January 7-Sunday, March 7, your photos will be due by **Friday, March 19**.

- Spring Shows: If the last day of your production falls between Thursday, March 11-Sunday, April 4, your photos will be due by **Friday, April 16.** *(Please note: We must receive your group photo for inclusion in the Showcase program by Friday, April 9.)*

All schools are required to submit the following photos:

1. One (1) high-resolution HORIZONTAL group photo including the cast, crew, and student orchestra. *This photo will be used as your school photo in the CAPA Marquee Showcase program.*
How to Name Photo: Group Photo, Name of your High School
Example: Group Photo, Amelia High School
2. At least three (3) but no more than ten (10) overall production photos
How to Name Photos: Production Image 1-10, Name of your High School
Example: Production Image 1, Amelia High School
3. Three (3) production photos of ***each*** performer eligible for Best Actor/Actress in a Jimmy Awards Qualifying Role. *This is a requirement of the Jimmy Awards®.*
How to Name Photos: First Name and Last Name of Performer 1-3, Name of your High School
Example: Amy Handra 1, Amelia High School

All photos must be JPG photos and at least 300 dpi (preferable 600 dpi) and will be uploaded using the Dropbox link on the school's web portal. *Please note: Most smart phones can capture a high-resolution photo; however, if the file size is less than 1 MB, the photo resolution will not be high enough.*

Performer Eligibility

Only high school students in grades 9-12 are eligible to be nominated for individual performance and technical awards.

Schools that have co-productions and/or shared performers, schools that allow homeschool students, or schools that allow students from other high schools to participate in their productions are eligible to participate; however, a student may only be nominated for their role in one musical production. In the event a student is nominated for multiple roles, the role that receives the highest adjudicator score will receive a nomination.

Casting

Casting must be completed and communicated to us **no later than Monday, January 25, 2027.**

If a school decides to double cast one or more roles, the school must select **one set of cast members** to be adjudicated. It will not be possible to adjudicate multiple students for the same role.

You must notify the CAPA Marquee Awards **no later than 8 weeks prior** to your production which cast you have selected for adjudication and all the dates that cast will be performing.

Actor / Actress

For the purposes of the CAPA Marquee Awards and the Jimmy Awards®, students are adjudicated in the category corresponding to their gender identification, not the gender of the role they are playing. *(For example, a female-identifying student recognized for a performance in the role of Tevye in FIDDLER ON THE ROOF will be nominated in the Best Actress in a Jimmy Awards Qualifying Role category).*

Non-Binary and Gender-Fluid Performers

For the purposes of the CAPA Marquee Awards and the Jimmy Awards®, students identifying as non-binary or gender-fluid may choose to either select the category in which they wish to be adjudicated (regardless of the gender of the role) OR they may be adjudicated based on the gender of the role they played.

Assessment

Teachers and students may be asked to complete printed or electronic surveys following certain program activities. CAPA may also request letters of support and testimonials. Surveys will evaluate participants' experiences and aid in the development of future program activities.

Primary and Secondary Contact

Each school must identify a primary contact person on the online application form. The primary contact should have regular access to phone and email as all major correspondence regarding the program will be directed to this person. In addition, a secondary contact person must also be identified on the online registration form. This person must be an employee of the school and can be a teacher, administrator, support staff, etc. The secondary contact person may not be a parent or a student.

Time Commitment

We know that many hours of hard work go into preparing a high school musical theatre production. During the school year, we will do our best to limit the additional time commitment from teachers. However, due to the yearlong nature of the program, communication throughout the year is necessary. To ensure the program runs smoothly, it is important you submit requested information to CAPA staff within the allotted time. It is also critical that you communicate information from CAPA staff to students (and parents, when applicable) about master classes, workshops, auditions, and the showcase.

Publicity and Social Media

One of the goals of the CAPA Marquee Awards is to enhance visibility of participating high school musical theatre productions and drama programs. CAPA may post production photos and show information from participating high school musicals on the CAPA and CAPA Marquee Awards websites and social media accounts. CAPA may also share show information with local media personnel.

We want to help promote your show! Please submit your electronic posters, marketing materials, and ticketing information as soon as these items are available. And don't forget to tag us with your photos on social media using @MarqueeAwards and #MarqueeAwards.

All participating high schools are **required** to feature the 2026-2027 CAPA Marquee Awards **Participation Statement** and logo as a part of their printed or digital program books. Inclusion of this information serves as the school's endorsement of the program. A copy of the CAPA Marquee Awards **Participation Statement** is included on page 17. A word version of this document is also available.

CAPA also encourages high schools to announce their participation and encourage ticket sales for the 2027 CAPA Marquee Awards Showcase in school newspapers, school/department websites, social media sites, and newsletters.

Adjudication

CAPA has secured a team of performing arts professionals with backgrounds in music, theatre, dance, design, and related fields to serve as adjudicators for the CAPA Marquee Awards Program. This group will be required to attend a training session, as well as commit to being impartial and objective to each production.

Evaluation Process

Three members of the adjudication panel will attend each production and will award points based on a set rubric. Adjudicators are responsible for evaluating how well each high school musical theatre production is meeting or exceeding its potential. The purpose of the evaluation process is to provide each school with educational feedback in the hopes of commending the notable achievements of each production and offering solutions to the aspects where productions could improve. Each production is evaluated against itself for consideration, rather than against all other school productions, charging schools to create the best possible work in their unique circumstance and environment.

Adjudicator Tickets

CAPA will contact schools to confirm which performances the three adjudicators will attend. Once your adjudication dates are confirmed, you are required to reserve two (2) complimentary tickets for each adjudicator and 2 complimentary tickets for CAPA for a total of 8 complimentary tickets.

Once you have the adjudicator and CAPA schedule, you may reserve your tickets using the following methods:

- Physical tickets held at Will Call. All pairs of tickets should be held under the name “CAPA Marquee Awards.”
- Email us a PDF of the individual tickets which we will email to adjudicators
- Text us electronic tickets that use a bar code or QR code and we will send it to adjudicator via text
- Email us a link to your ticketing site where adjudicators will be able to select their own seats using a complimentary code that you provide

Please note: The three adjudicators assigned to your production may or may not attend the same performance.

Feedback

Adjudicators will provide written feedback on performances by students in lead, supporting, and ensemble roles, as well as student orchestra, dance execution, technical execution, direction, and the overall production. Feedback is designed to function as an educational tool, not strictly a review or critique. CAPA will email adjudicator feedback to the primary contact teacher after award nominations are announced. While we discourage the use of AI, adjudicators may use it to finesse the language of their feedback but are never permitted to use it to generate feedback.

Confidentiality

Feedback and scoring will be submitted through a secure online form. Adjudicators will not provide oral critiques following the performance, nor should schools expect to receive scores verbally. *Adjudicators must not discuss their opinions, evaluations, scores, or feedback with anyone, in any format.* This includes faculty, staff or students from participating high schools, other adjudicators, colleagues, reviewers, social media networks, etc. Please do not contact adjudicators with questions. All inquiries should be directed to marqueeawards@capa.com.

Scoring

Using a scoring rubric, adjudicators will issue scores to designate awards for artistic excellence in each award category. While numeric scores will not be shared, each criterion falls on the rubric will be shared.

Evaluation Criteria

Adjudicators will evaluate students and school productions on the execution of various performance and production elements including:

Acting

- **Believability:** relationship with other characters; motivation; consistency; commitment to role
- **Voice & Diction:** projection; articulation; dialect execution (if applicable)
- **Interpretation:** presence of active objectives/goals; strong and appropriate vocal and physical choices; character development

Singing

- **Accuracy:** pitch; rhythm; intonation
- **Tone:** quality; resonance
- **Diction:** articulation; vowel shapes; appropriate use of consonants
- **Technique:** breath support; posture; placement; phrasing

Movement & Dancing

- **Choreography:** footwork; body position; energy; precision; rhythm/tempo
- **Characterization:** artistic expression within choreography; intention; facial expressions; gestures
- **Execution:** preparedness; natural integration of blocking; motivation of movement

Stage Presence

- **Energy:** control over nerves; focused energy; ability to be seen and heard
- **Adaptability:** the ability to “think on feet” and stay in the moment; flexibility to accommodate present circumstances
- **Presence:** fully engaged and present in the world created; strong understanding of role in the greater story

Teamwork

- **Listening skills:** the ability to listen to each other and react accordingly
- **Focus:** knowing where focus should be given and making choices that support and do not hinder focus
- **Group Dynamics:** awareness of the group dynamics and how to work together as a team

Dance Execution

- **Knowledge of Choreography:** choreography is fully mastered and executed; there is no watching of others and full confidence on display
- **Technical Skills:** no technical errors and misalignments; mastery of the quality of movement and dance style
- **Tempo/Rhythm:** dancers follow the tempo, rhythm, and beat
- **Performance Skills:** dancers are focused and draw the audience in throughout their performance

Orchestra

- **Sound Production:** instruments are in tune within sections and across the orchestra; appropriate and professional tone production and style
- **Balance:** complete balance between orchestra and stage; sections within the orchestra are balanced with each other throughout the production
- **Accuracy and Style:** melodic and rhythmic accuracy
- **Professionalism:** students are dressed appropriately; are fully engaged and focused; demonstrate the ability to adjust to unexpected situations as needed

Technical Execution

- **Transitions:** seamless technical movement from scene to scene
- **Timing:** cues are called and executed masterfully maintaining perfect timing
- **Technical Aspects:** all technical aspects of the show have been given careful consideration and are exceptional
- **Cohesion:** all technical aspects work together seamlessly, and the overall design and execution create an exceptional, technical production

Direction

- **Interpretation:** communication of major ideas, themes, and emotions to the audience
- **Staging/Blocking:** seamless transitions between scenes and musical numbers; incorporation of stage pictures that contribute to and aid in the telling of the story
- **Coordination:** all elements of the production (set, costume, props, lights, performances, etc.) are inter-related, contribute to telling the story, serve the needs of script, and communicate the vision of the director
- **Utilization of Existing Resources:** the ability to turn the challenges of the school's existing space and resources into assets through creativity, ingenuity, and resourcefulness

Overall Production

- **Theatricality:** appropriateness of material for student performers; overall communication of major ideas, themes, and emotions to the audience through successful execution of score and book; the ability to capture the style and period of the piece
- **Cohesion:** all direction, performance, and design elements work together to create a seamless, impactful and entertaining production
- **Execution:** ability to overcome any unexpected obstacles; prepared and audience-ready; a spirit of teamwork is on display with team members who conduct themselves with a professional attitude
- **Utilization of Talent:** executed with enthusiasm, talent, and originality; demonstrates the diverse talents of the student population

Award Categories

The CAPA Marquee Awards program gives participating schools and students the opportunity to win awards for artistic excellence in several categories. The awards categories for the 2026-2027 season include:

Nominees in all award categories will receive a nomination certificate. Winners in all award categories will receive two CAPA Marquee Awards trophies (1 for individual winner/theatre program and 1 for the school). All nominees and winners will receive special recognition at the Awards Showcase.

Category Eligibility

Best Musical Production

Five high school musical theatre productions will be recognized as nominees in this award category. The five nominees and one winner will be determined by adjudicator scores. High schools receiving nominations for Best Musical Production will be invited to perform a number from their nominated musical at the Awards Showcase.

Best Performer in a Jimmy Awards Qualifying Role Nominee

To be eligible to participate in The Jimmy Awards®, the Best Actor and Best Actress winners must have played a NHSMTA®-recognized qualifying role in their school's production. For this reason, only students playing a NHSMTA®-recognized qualifying role in their high school's production will be eligible for the CAPA Marquee Awards' Best Actor and/or Best Actress in a Jimmy Awards Qualifying Role. (*Jimmy Awards-qualifying roles may be classified as either **leading** or **supporting** roles within the CAPA Marquee Awards program.*)

Due to the nature of the award, the Best Performer in a Jimmy Award Qualifying Role nominees and winner will be determined by both a **production** and **audition** score. Qualifying students receive a *production score* from the adjudicators that attend their school productions. The adjudicated score will count as 65% of the total score.

Based on school production scores, we will notify our 30 semifinalists on **Monday, April 5**.

Semifinalists must attend a panel audition on **Saturday, April 10**, from **10am-3:30pm** at the Ohio Theatre. The panel audition will consist of a song and dance audition. The scores from the panel audition will count as 35% of the total score and will be combined with semifinalists' production scores to determine our finalists and winners.

The ten finalists (5 actors and 5 actresses) receiving nominations for Best Actor and Best Actress in a Jimmy Awards Qualifying Role will be announced on **Monday, April 12** at **3pm** and will be invited to perform a solo from their nominated role at the Awards Showcase as part of the Best Actor and Best Actress numbers.

Please note: Only registered high school students will be eligible to receive this award.

Best Performer in a Leading Role

For purposes of this awards program, a leading role will be classified *as a principal role that carries the primary responsibility for advancing the story and is featured more prominently than supporting, ensemble, or feature roles. A performer in a leading role must have both substantial solo lines of dialogue and a featured musical solo during the musical production.*

All leading roles will be automatically adjudicated.

Ten student performers (5 actors and 5 actresses) will be recognized as nominees in this award category. Nominees and winners will be determined by adjudicator scores.

Please note: Only registered high school students will be eligible to receive this award.

Best Performer in a Supporting Role

For purposes of this awards program, a supporting role will be classified as *a role below that of a leading role and above that of a bit or ensemble part. A performer in a supporting role must have both solo lines of dialogue and perform substantial solo singing during the musical production.*

All Jimmy Awards-qualifying roles will automatically be adjudicated. Other supporting roles may be adjudicated if the total number of Jimmy Awards-qualifying roles does not total eight (8) roles.

Ten student performers (5 actors and 5 actresses) will be recognized as nominees in this award category. Nominees and winners will be determined by adjudicator scores.

Please note: Only registered high school students will be eligible to receive this award.

Best Direction

Five directors will be recognized as nominees in this award category. The nominees and winners will be determined by adjudicator scores.

Outstanding Ensemble

Five ensembles will be recognized as nominees in this award category. The nominees and winners will be determined by adjudicator scores.

Please note: At least 80% of the total ensemble must be high school students to be eligible for Outstanding Ensemble. No more than 20% of the total ensemble may consist of non-high school students.

Outstanding Dance Execution

Five high school musical theatre productions will be recognized as nominees in this award category. The nominees and winners will be determined by adjudicator scores.

Please note: At least 80% of the total ensemble must be high school students to be eligible for an Outstanding Dance Execution. No more than 20% of the total ensemble may consist of non-high school students.

Outstanding Student Orchestra

Five student orchestras will be recognized as nominees in this award category. The nominees and winners will be determined by adjudicator scores.

Please note: At least 60% of the total orchestra must be high school students to be eligible for Outstanding Student Orchestra. No more than 40% of the total orchestra may be adults and/or professionals. If the conductor plays with the orchestra, she/he is counted as an adult and/or professional musician, unless the conductor is a registered high school student.

Outstanding Technical Execution

Five productions will be recognized as nominees in this award category. The nominees and winner will be determined by adjudicator scores. If the school has a student stage manager, that student will also be individually recognized.

Please note: At least 80% of the total technical run crew must be high school students to be eligible for Outstanding Technical Execution. No more than 20% of the total technical run crew may consist of non-high school students.

Backstage Excellence Award

Five backstage crews or group of students demonstrating excellence behind-the-scenes will be recognized as nominees in this award category. Teachers are responsible for nominating students for this award. Guidelines for nominating students for the Backstage Excellence Award are available on page 18. An adjudication panel will select the final nominees and winners in this category.

Outstanding Student Designer

Five students demonstrating excellence in costume, hair & makeup, lighting, scenic, sound, and props design will be recognized as nominees in this award category. Students are responsible for applying for this award. The guidelines and application instructions for Outstanding Student Designer are available on page 19. An adjudication panel will select the final nominees and winners in this category.

National Student Reporter

The National High School Musical Theatre Awards® is seeking two Student Reporters from around the country to travel to New York to cover the 2027 Jimmy Awards on social media on both the official Jimmy Awards channels and the student reporters' personal channels. Up to two outstanding high school student(s) participating CAPA Marquee Awards schools will be nominated to represent central Ohio in the national competition. The guidelines and application instructions are available on page 20. An adjudication panel will select the winner(s) in this category.

26-27 Updates: Best Performer in a Leading/Supporting Role

To provide better distinction between leading and supporting roles, we have revised the CAPA Marquee Awards Qualifying Roles List for the upcoming season.

Each participating school may have **up to eight (8) eligible performance roles adjudicated** for the CAPA Marquee Awards, or the total number of qualifying Jimmy Awards roles—whichever is higher.

How Roles Will Be Selected

- All Jimmy Awards-qualifying roles will automatically be adjudicated.
- Jimmy Awards-qualifying roles may be classified as either **leading** or **supporting** roles within the CAPA Marquee Awards program.
- Jimmy Awards-qualifying roles must appear on the [Jimmy Awards Qualifying Roles List](#).
- If your production includes fewer than eight Jimmy Awards-qualifying roles, you may select additional eligible roles to reach the maximum of eight adjudicated roles.

The director may also select up to two (2) additional supporting roles to be adjudicated, and these two (2) additional roles will be selected from: Eugene Krabs, Pearl Krabs, Karen the Computer, and Perch Perkins.

On Monday, April 5, Best Performer in a Jimmy Awards Qualifying Role Semifinalists will be notified.
At 3 pm on Thursday, April 8, CAPA will announce the nominees for each award on our website.
At 3pm on Monday, April 12, CAPA will announce the Best Performer in a Jimmy Awards Qualifying Role Finalists.

Awards Showcase

On Thursday, May 6 at 7:30 pm, the CAPA Marquee Awards will present a Tony Awards®-inspired showcase at the Ohio Theatre honoring schools, students, and directors for artistic excellence in high school theatre. This event will be a tribute to the enthusiasm, dedication, and accomplishments of central Ohio's vibrant high school theatre programs. Participants will have the opportunity to receive awards and perform on the Ohio Theatre stage as a part of the evening's program. Students, faculty, administrators, staff, and parents from participating high schools are encouraged to promote and attend the awards showcase.

Performance Opportunities

The Awards Showcase gives students from all participating high schools the chance to perform as part of our school ensemble at a professional venue and work with a team of theatre and music professionals. It will also give one technical student from each school a chance to work backstage alongside our professional stagehands at the Ohio Theatre.

Throughout the course of the evening, audiences will experience the following performances:

Opening & Closing Number

Each participating school is required to select two student representatives **(1 male voice and 1 female voice)** to perform as part of the Student Ensemble in the opening and closing numbers of the 2027 CAPA Marquee Awards. Student representatives should be ones without scheduling conflicts during mandatory rehearsals (see 'CAPA Marquee Awards Rehearsals'). **When deciding who will represent your school in the Student Ensemble, make sure to send students who are conflict-free for all rehearsals.** (See 'Rehearsal Schedule')

Please send students who have strong singing and dance experience/skills and those who have stage experience. While our team can adapt choreography to various levels of ability, we have a very short time for these students to learn two, five-minute numbers with challenging vocals and choreography. We want to set every student up to have a successful experience and do not want any of our ensemble performers to feel overwhelmed by the material.

Failure to send two students (1 male voice and 1 female voice) to perform in the Showcase may result in a school not being accepted back into the program in subsequent years.

Additionally, semifinalists for Best Performer in a Jimmy Awards Qualifying Role will be invited to perform in the opening/closing numbers. The 10 finalists for Best Performer in a Jimmy Awards Qualifying Role will be required to perform in the opening and closing numbers.

Best Musical Production Number:

Each of the five high schools receiving nominations for Best Musical Production are required to perform one production number from their show during the 2027 CAPA Marquee Awards.

Song Selection & Submissions: After the nominations are announced, the directors from each nominated school must submit the three ranked production numbers they wish to perform by

7pm on Monday, April 12. The full conductor score, libretto, and individual instrument books must be received by **7 pm on Tuesday, April 13.** Your musical submission should include all the notations, cuts, and markings used in the school's production.

Final song selection and arrangement will be determined by the CAPA Marquee Awards creative team. Once the number is selected, the director must submit a cast list for the program and a video showing the full production number—including any/all dialogue, vocals, and blocking by **7 pm on Friday, April 16.** The production video will help our creative team prepare important technical elements, so it is imperative these are accurate and complete.

Jimmy Awards Finalist Number:

The ten Jimmy Awards finalists (five Best Actor and 5 Best Actresses) will perform an excerpt of a song from their nominated role during the Jimmy Awards Finalist numbers at the 2027 CAPA Marquee Awards. Students will be responsible for submitting their song requests at the Panel Audition on Saturday, April 10. **Final song selection and arrangement will be determined by the CAPA Marquee Awards creative team.**

After the nominations are announced, the directors from each nominated student's school must submit the full conductor score, libretto, and individual instrument books for the solo song by **7 pm on Tuesday, April 13, 2027.**

Attendance

Attendance at all required rehearsals is mandatory for participation in the 2027 CAPA Marquee Awards Showcase to maintain a high level of artistic and production quality in such a short period of time. In the rare event of extraordinary circumstances, the CAPA Marquee Awards reserves the right to waive or modify this requirement. However, the focus of the rule is not on the reason why a student may miss a rehearsal, but on the impact that any cast member missing a rehearsal may have on the group as a whole.

Showcase Costumes/Attire

The Awards Showcase is a red-carpet event and celebratory attire is encouraged!

All students performing in the Opening/Closing Numbers will be required to wear the following:

MALE-IDENTIFYING PERFORMERS: Black pants (no jeans), a solid, colorful shirt (no black or white), black shoes. Tie optional.

FOOTWEAR FOR MALE-IDENTIFYING PERFORMERS: Black tennis shoes, black or nude character, jazz, or dress shoes with a low heel (2 inches or less). All footwear must be closed-heeled and closed-toed and appropriate to dance in.

FEMALE-IDENTIFYING PERFORMERS: Black pants (no jeans) or black skirt and a solid, colorful top (no black or white) OR a solid-colored dress or jumper (black is permitted if wearing a dress or jumper). If a skirt or dress is worn, nude or black tights must be worn. Women should wear black or nude-colored shoes.

FOOTWEAR FOR FEMALE-IDENTIFYING PERFORMERS: Black tennis shoes, black or nude character, jazz, or dress shoes with a low heel (2 inches or less). All footwear must be closed-heeled and closed-toed and appropriate to dance in.

NON-BINARY/GENDER-FLUID PERFORMERS: Select from any of the above attire and footwear options.

Students performing as part of the Best Musical Production numbers will wear costumes decided on by their productions' directors. Some things for directors to consider when choosing what students will wear for Best Musical Production Number:

- Please keep in mind the purpose of the showcase is to *celebrate* your production and not recreate it. You are certainly welcome to wear production costumes, but a school performing A number that showcases the students and their talents in a simple and honest way can be just as impactful and effective. So, dressing in all white, all black, all colorful—or using a base outfit and incorporating some costume pieces would work well. You are also certainly welcome to use production t-shirts and pants/jeans, if you don't want to wear any costumes.
- Limited pieces and small handheld props will be allowed.
- Your rehearsal time on stage during the technical and spacing rehearsal will be very limited so again, the simpler the better.

Students performing in the Jimmy Awards Finalist Number should plan on wearing either red-carpet attire or their character costume.

Teachers are responsible for nominating students for the Backstage Excellence Award and may only nominate one group of students for this award. Students should be nominated for contributing to their school's participating 2026-2027 CAPA Marquee Awards Program musical. Nominations will be reviewed by a panel of local theatre professionals who will select winners to be honored at the CAPA Marquee Awards Showcase on Thursday, May 6, 2027.

Teachers will be able to submit nominations starting on **Thursday, October 8, 2026**. The deadline for nominations is **NOON on Wednesday, March 31, 2027**.

Nominees and winners will be determined through an application process. *Design work for a production not adjudicated by the CAPA Marquee Awards is ineligible.*

Students may only submit **one** application for this award, but the design application may include multiple design areas. The design must be from a CAPA Marquee-adjudicated production from the 2026-2027 school year. Applications will be reviewed by a panel of local theatre professionals who will select winners to be honored at the CAPA Marquee Awards Showcase on **Thursday, May 6, 2027**, at the Ohio Theatre.

Students who are selected as final nominees for this award will receive two complimentary tickets to the Awards Showcase. Students will be able to submit applications starting **Thursday, October 8, 2026**. The deadline for applications is **NOON on Wednesday, March 31, 2027**.

Applicants should create a video up to 60 seconds in length showing or describing how they would uniquely cover The Jimmy Awards on social media, focusing on promoting the live stream of the Jimmy Awards ceremony. They should use **one** of the following prompts:

- You are on the bus with the nominees heading to the Minskoff Theatre, where they will rehearse and perform on a Broadway stage later that day.
- You are at lunch with the nominees after their first technical and staging rehearsal on a Broadway stage. In about six hours, they will be performing in front of a sold-out audience and worldwide livestream.
- You are interviewing Broadway talent and/or Jimmy Awards Judges on the red carpet before they take their seats in the audience for the ceremony.

The video should include at least one unedited segment of at least 20 seconds in length with the applicant speaking directly to camera. The videos must not include any performance footage; the content of the videos is otherwise up to the applicant. Any pre-recorded music used must be royalty-free.

We want to see your personality shine in this video! Show us how you would use your unique perspective to build interest in and awareness of the Jimmy Awards. This is an opportunity to showcase your skills in event coverage, visual storytelling, video editing, and social media.

Good Standing Guidelines



To uphold the integrity of the program and promote a positive experience for all involved, all participating schools must adhere to the following:

- **Professional Conduct**
 - Maintain a respectful and inclusive environment for students, staff, adjudicators, and program representatives.
 - Proactively address any concerns or questions in a constructive and timely manner, and through the appropriate channels.
- **School Meeting Attendance**
 - The primary and/or secondary school contacts must attend the annual in-person School Meeting at the Ohio Theatre on Thursday, September 17 from 5:30-8pm.
- **Shows and Roles Eligibility**
 - Schools must perform a published musical, operetta or revue (either currently held by a licensing house or in the public domain) presented with the approval or permission of the original creators, publishers, or their representatives.
 - Schools must produce one of the full-length musicals approved by the National High School Musical Theatre Awards within the designated adjudication window. The 2026-2027 adjudication window is Thursday, October 8, 2026 through Sunday, April 3, 2027.
 - Communicate the production's eligibility for each category accurately by the stated deadlines.
- **Confirmation of Undecided Information**
 - Production selection must be **decided** and **communicated** to us by Friday, December 11, 2026
 - Production rights must be **paid and secured** no later than Friday, January 22, 2027.
 - Production **casting** must be complete no later than Monday, January 25, 2027.
- **Production Information Form and Production Ticket Requirements**
 - All schools are required to submit a Production Information Form three weeks prior to their production.
 - Schools are required to provide production tickets for each adjudicator and CAPA as communicated by the CAPA Marquee Awards.
- **Marquee Participation Statement in Production Program**
 - Include the 26-27 CMA Participation Statement in your school's production program.
 - Share program materials and updates with students and families to maximize participation.

- **Best Performer in a Jimmy Awards Qualifying Role Panel Audition**
 - If your student has submitted their Panel Audition Intent to Participate Form and is selected as one of our 30 semifinalists for Best Performer in a Jimmy Awards Qualifying Role, they must attend the Panel Audition on Saturday, April 10, 2027, from 10am-3:30pm.
- **Showcase Ticket Reservation Form**
 - Each school is required to submit their showcase ticket reservation form no later than Friday, January 8, 2027.
- **Showcase Ticket Purchase and Attendance Requirements**
 - The CAPA Marquee Awards requires each school to purchase 25 tickets to the Awards Showcase at the discounted student ticket price of \$15 each (\$375 total) regardless of nominations. The 25 required tickets must be purchased and paid for by Friday, March 12, 2027, and should be filled with attendees from your school community.
 - Communicate proactively about financial challenges or delays.
 - Each school, regardless of nomination status, must be visibly represented in the theatre during the CAPA Marquee Awards Ceremony. Schools are encouraged to make every effort to fill their designated seating area and demonstrate enthusiastic support for their students and fellow participating schools.
- **School Representation in Showcase**
 - Each participating school is required to select two student representatives (1 male voice and 1 female voice) to perform as part of the Student Ensemble in the opening and closing numbers of the 2027 CAPA Marquee Awards.
 - Student representatives should be ones without scheduling conflicts during mandatory rehearsals (see 'CAPA Marquee Awards Rehearsals in handbook'). When deciding who will represent your school in the Student Ensemble, make sure to send students who are conflict-free for all rehearsals.
 - Students must attend all rehearsals and technical run-throughs as scheduled. No absences will be permitted.
 - Best Performer in a Jimmy Qualifying Role Participation (if applicable):
 - All finalists in the categories of Best Actor and Best Actress in Jimmy Awards Qualifying Role are also required to perform in a medley and the opening and closing numbers at the CAPA Marquee Awards Ceremony.
 - All finalists must attend all rehearsals and technical run-throughs as scheduled. No absences will be permitted.
- **Best Musical Performance Requirements (If applicable):**
 - The five schools nominated for Best Musical are required to perform one production number from their nominated show during the CAPA Marquee Awards Ceremony.

- Performers in the Best Musical production number must attend the technical and dress rehearsal as scheduled.
- **Production Photo Submission Requirement**
 - All schools are **required** to submit:
 - One high-res horizontal group photo including cast, crew and orchestra (if applicable).
 - At least three (3) but no more than ten (10) overall production photos
 - Three (3) production photos of each performer nominated for Best Actor/Actress in a Jimmy Awards Qualifying Role. This is a requirement of the Jimmy Awards®.
 - Photo Deadlines:
 - **Fall Shows:** If the last day of your production falls between Thursday, October 8-Sunday, December 13, your photos will be due by Friday, December 19.
 - **Winter Shows:** If the last day of your production falls between Thursday, January 7-Sunday, March 8, your photos will be due by Friday, March 12.
 - **Spring Shows:** If the last day of your production falls between Thursday, March 11-Sunday, April 4, your photos will be due by Friday, April 16. (Please note: We must receive your group photo for inclusion in the Showcase program by Friday, April 9.)
